Institute of Medical Sciences, Mangalore for purpose of Recognition of MS(Ophthalmology) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (18.07.2016) and decided to recommend to the Central Government that MS(Ophthalmology) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.
