f) against "Sri Ramachandra University, Chennai" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Diploma in Tuberculosis & Chest Diseases"

(This shall be a recognised medical qualification when granted by Sri Ramachandra University, Chennai in respect of students being trained at Sri Ramachandra Medical College & Research Institute, Chennai on or after May, 2012.

g) against "West Bengal University of Health Sciences, Kolkata" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Pathology)"

MD(Pathology)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Medical College, Kolkata on or after May, 2012.

Note to all: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

2. Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
