

J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council 'Assessor's Report (21.06.2017) and decided to recommend to the Central Government that MS(General Surgery) qualfication against increased intake from 04 to 08 seats and renewal of recognition for 04 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
