I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 15/02/2018 considered the Council Assessor's Report (June, 2017) and E-mail compliance dated 05/01/2018 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD/MS(OBG) qualfication against increased intake from 02 to 06 seats and renewal of recognition for 02 seats at A. J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2017) and E-mail compliance dated 05/01/2018 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(OBG) qualfication against increased intake from 02 to 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that the recognition of MD/MS(OBG) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be renewed.
