

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of MS(Orthopaedics) qualification for 04 to 08 seats in respect of students being trained at A. J. Institute of Medical Sciences & Research Centre, Mangaluru under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.*
