I am directed to state that the Board of Governors at its meeting held on 30.01.2019 considered the Assessment Report (03.06.2018) on the standard of examination and other teaching facilities available at A. J. Institute of Medical Sciences, Mangalore for purpose of Recognition of MD(Pathology) qualification against increased intake from 04 to 05 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under: -

"The Board of Governors considered the Council Assessor's Report (03.06.2018) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 04 to 05 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."


